WELLS CATHEDRAL ORATORIO SOCIETY ANNUAL REPORT AND ACCOUNTS FOR THE YEAR ENDED 30 JUNE 2019 TRUSTEES ANNUAL REPORT

Background History

The Wells Cathedral Oratorio society has been in existence for over a hundred years. Originally the Wells Music Association, it joined forces with the Street, Shepton Mallet, and Wedmore Musical Societies. Since 1947, the Society has performed major choral and other works in Wells Cathedral twice every year until the 2013/14 season when the Society moved to three concerts a year. The Society also sponsors a "Come and Sing" day in the summer.

The chorus numbers around 160 singers drawn from a wide area in Somerset and is one of the leading choral societies in the South West of England. Despite its name it has always been independent of Wells Cathedral and became a registered charity in its own right in 1988. Legal and administrative information may be found on page 9.

Objects of the Society

- To educate the public in the art and knowledge of music, and in particular j choral music by the presentation of choral concerts and other related activities.
- To assist and further such charitable institutions and purposes as the Committee shall from time to time determine.

The charity's trustees have complied with their duty to have due regard to the guidance on public benefit published by the Charity Commission in exercising their powers or duties. Our Society contributes significantly to the cultural life of Wells and the surrounding area, and we are proud of our efforts to reach out to all music lovers through a wide choice of music, some of which is rarely heard. Our Come and Sing Day provides for those local and other singers from further afield to come and enjoy with us perhaps a new opportunity and experience in choral singing and is much appreciated.

Management

The Committee of the Society undertake arrangements for concerts and other related events, management of the Society's affairs and the control of finance. The committee members are drawn from the membership of the Society and stand for re-election every year. The Committee members who served during the last year are listed on Page 9.

Review of the year

Our concert season was varied and commenced with a commemorative programme in remembrance of the 100th anniversary of the ending of the first world war. The concert held on 10th November, the vigil of Armistice day itself, featured Jonathan Dove's cantata "To an unknown Soldier" followed in the second half by the Faure Requiem. The composer Jonathan Dove attended and we were accompanied by the London Mozart Players. We continued with our now traditional offering of the Messiah at Christmas. A decision was taken after a review of revenue and cost to substitute Mendelssohn's Elijah for the more elaborate and expensive Elgar Apostles for our March concert.

A change of conductor from Matthew Owens for the final four rehearsals and performance of Messiah as well as the uncertainties surrounding his availability to conduct the spring concert was partly also responsible for this change of programme. Our thanks must go to Stuart Beer who returned at very short notice from Singapore to take over the final rehearsals and conductor's baton for Messiah.

In the event we were fortunate to secure Matthew for rehearsals of Elijah at St Thomas' Church as well as at the last minute to conduct the performance itself. These changes and uncertainties resulted in a loss of ticket sales for the final two concerts due to the disruption of the programme, and credit must be due to our chairman Robin Duys and your Committee for holding the concert season together during a difficult time. The Society was complemented on the quality of the seasons singing in various concert reviews.

Our Future Plans

Our Come and Sing Day previewed the Morten Lauridsen choral work Lux Aeterna, rehearsed during the day and performed in the evening in Wells Methodist Church. This will form part of our concert on 16th November. The concert opens with Arvo Part's "Cantus in memoriam Benjamin Britten". This short piece for strings will be followed by Morten Lauridsen's "Lux Aeterna". In the second half we will perform our Patron, John Rutter's Magnificat, with the soprano soloist Elisabeth Atherton, returning again after her outstanding performance in Elijah. We will be accompanied by the prestigious English Chamber Orchestra.

Our Christmas offering is Handel's Messiah, on 7th December. This is the sixth season we have performed Messiah and we will be accompanied by Music for Awhile on Baroque instruments with soloists Elizabeth Atherton, soprano, Tim Morgan, counter tenor, Peter Auty, tenor and Ben McAater, bass.

The spring concert on March 28th is an 18th century classical concert of music by Haydn and Mozart. We open the concert with a short choral motet "Insanae et vanae curae" by Haydn followed by his symphony no 104 in D major, (the London). After the interval we sing Mozart's Requiem in D minor K 626. For this concert we will be accompanied again by the English Symphony Orchestra, with soloists Alexandra Oomens, soprano, Helen Charleston, alto, James Oxley, tenor, and Grant Doyle, bass.

Much work has been done during the year by Matthew Owens and the Music Committee in preparing this programme, and we have been lucky to have the support of Matthew for the last 14 years. We wish him well in his new career in Belfast, and welcome our prospective new conductor for his year, Jeremy Cole. Our thanks also go to our Concert Manager Robin Walker who has secured the orchestras and soloists for this year's programme.

The preliminary budget for 2018/9 anticipated an overall loss of over £13,000 by reducing reserves to just over £25000, but we have been able to cut this to just over £7000 through stringent cost control and the change of programme. We were helped by much better than anticipated ticket sales for the Dove/Faure thanks partly to publicity from SSAFA who made a substantial collection at the door. Our Messiah ticket sales were however well below that of 2017 (which was a sell out) and sales for Elijah were also much lower than anticipated. Through last-minute marketing and publicity we managed to secure something of a recovery in ticket sales for Elijah and the last minute availability of Matthew as our conductor also helped. Our projections and budget for this coming season show a recovery with a small surplus but as ever these projections will need a strong marketing and publicity plan to enable them to be achieved. We have an exciting and well thought out programme of oratorio music this year in the best traditions of our long history. As this is the last year of our chairman's tenure of office the Trustees would like to express their deep appreciation for his untiring work behind the scenes as well as his management of a difficult 2018/9 season.

Notes to the accounts.

Basis of Accounting

The accounts have been prepared under the accruals basis which ensures that income and costs from events falling within the accounting period are reported in the Statement of Financial Activities.

Income received or costs expended which relate to future period are not disclosed in the Statement of Financial Activities but form part of the Balance Sheet. This is consistent with the accounting policy used in previous years.

Note 1 Donations

Donations from members, friends and others total £903. No single donation exceeded £250.

Note 2 Bank Interest

Earned on the Societies COIF and Lloyds deposit accounts

Note 3 Gift Aid tax refund

Gift aid has been applied for but remains outstanding as at year end.

Note 4 Concerts and Events Prior Year

Late invoices in respect of the year ending 30 June 2018 and not provided for in the previous year's accounts total £1,078

Reserves Policy

All activities and income are considered to be within a general, unrestricted fund. The Society takes the view that the level of reserves need (a) to provide a short-term cash flow buffer for the Spring concert in each season. The treasurer's assessment of the maximum required for this is £12,500.

(b) to provide for an uninsurable loss on concerts greater than forecast, for example catastrophic ticket sales. The trustee's assessment of the maximum risk is £12,500.

Our base level of required reserves to cover (a) and (b) is £25,000

Our concert planning and budgeting process aims to deliver an annual result between a deficit and a surplus of £10,000. Since in the long run we will neither accumulate or deplete reserves, it is expected that will accumulate cash in some years to provide funds for concerts demanding large resources up to £17,500.

Current reserves

Our current reserves are £31,295.

Report of the Independent Examiner to the Trustees of Wells Cathedral Oratorio Society

I report on the accounts of Wells Cathedral Oratorio Society for the year ended 30 June 2019

Respective responsibilities of Trustees and Examiner
